Outpatient Recovery Services

The Yucca Valley Center for Change provides outpatient services which include comprehensive alcohol and drug treatment to empower individuals who want to live drug free. Our program offers assessment and evaluation, individual and group counseling sessions, adolescent treatment, introduction to 12-step meetings, family social events, and community services. Our program's integrated social model approach provides a safe and sober environment for healthy socialization. We accept self-referrals, as well as referrals from Probation, Children Family Services, and other service providers.



DUI Services

Our center offers a DUI program certified by the State Department of Alcohol and Drug Services and approved by the County of San Bernardino to provide alcohol and drug education and prevention services. Our participants have been convicted of Driving-Under-The-Influence (DUI) by a court of law and have been mandated by the Department of Motor Vehicles to complete a DUI program in order to reinstate their driving privileges.

Rockin' Recovery Center

The Yucca Valley Center for Change serves as a one-stop recovery center which provides a safe, clean and sober environment for individuals by fostering peer support through recovery oriented activities and services. Self-help groups, 12-step meetings, family and community events, vocational assistance, and information and referrals to community resources are available. Additionally, groups focusing on life skills, parenting, anger management, nutrition, smoking cessation, relaxation and early recovery support are offered. The recovery center provides computer and internet access, meeting room space and serves as a community forum for persons in recovery. All services are free. We accept self-referrals as well as referrals from community providers.
